

## **Visa 'Spend and Win' Contest Terms and Conditions**

3. The Contest period shall commence from 13 April 2017 until 28 May 2017 ("the Contest Period").
4. The Contest entry requirement are as follows:

(i) The Participant(s) are required to spend:

- 1) RM150 and above through Visa's Card; or
- 2) RM50 and above through Visa payWave

for such amount at any of AEON Stores, AEON MaxValu and AEON Wellness Shop only ("Participating Outlet") in a single receipt or combination of two receipts;
