A) ORGANISER

1. This "AEON MEMBER GREAT FRIDAY SALE CONTEST" ("Contest") is organised by AEON CO. (M) BHD. ("the Organiser").

B) CONTEST PERIOD

1. This Contest begins on **29 September and ends on 30 September 2018** ("Contest Period").

C) ELIGIBILITY
