Personal Data Protection Notice

AEON CO. (M) BHD. (126926-H) ("AEON") respects and values the privacy of individuals with regards to personal data and strive to protect the same in accordance to the Personal Data Protection Act 2010 ("the Act"). As part of AEON's efforts to protect your personal data, this Personal Data Privacy Notice is formulated in accordance with the Act. For the purpose of this Personal Data Privacy Notice, "Personal Data" shall have the meaning as ascribed in the Act.

This Personal Data Privacy Notice applies to any person whose Personal Data is processed by AEON including but not limited to AEON's customers, employees, suppliers and tenants.

1. This Personal Data Notice serves to inform you how your Personal Data is being processed by and/or on behalf of AEON.
2. The Personal Data processed by AEON may include your name, contact details, date of birth, email address and any other personal data required for the purposes set out in the paragraph below.
